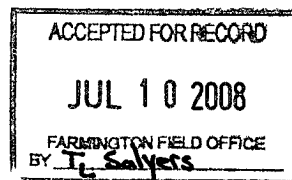

Elm Ridge Exploration Co, LLC has reached a TD of 1388' on 6-25-08. 6-26-08 we ran 32 Joints of 5 1/2" 15.5# J-55 casing down a 7 7/8" hole to 1373'. We then mixed and pumped 170 sks of Type G cement with 2% enconolite, 5# gilsonite and 1/8# polyflake for the first stage of cementing mixed and pumped 130 sks of Type G cement with 2% calc, 5# gilsonite and 1/8# polyflake for the second stage of cementing, had 15 bbls of good cement circulated to pit. Pressure tested well to 1500 PSI for 30 plus minutes. BLM was notified but not present to witness job. ✓
