Tail w/50 sx Type 5 cement w/2# PhenoSeal & 1/4# celloflake/sx (221 cu ft total slurry). Circulate 10 bbls cement. Rig released @ 1600 hrs on 7/10/08. Pressure test will be reported on completion sundry.
