7/9/08 Frac w/ 597 bbls of borate crosslinked gel with 652,713 SCF of N2 and 110,000# of 20/40 BASF sand.

7/13/08 RU JC Well Service. Clean out to PBTD with air. Ran 61 jts of 2-3/8", 4.7#, J-55, EUE8rd tubing and set @ 2054' KB. Ran pump and rods. Turned well over to production.
