Cement 2nd stage w/565 sx (145 bbls) 50/50 POZ w/3% Gel, 0.6% Halad-9, 0.1% CFR3, 5#/sx Gilsonite, 0.25#/sx Floseal and tail w/50 sx (11 bbls) Class "G" cement w/0.4% Halad 344. Circulated 30 bbls of cement to surface. Tested casing to 1,500 psi.
