High Plains' research has revealed that the highest recovery in the Rio Puerco Mancos Field is from a well that was frac'd with a large foamed diesel frac, not from a horizontal well or well with a horizontal lateral. Therefore, High Plains plans to log the unlogged openhole, design a completion similar to Johnson 6-16 and frac with the same volume of foamed diesel and prop. Logging is planned for next month with completion and stimulation this fall, after the monsoon season is over.
