

13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. On 7/23/08 a CFP with green bio ball was set at 6,260' the above well was then perforated in the Point Lookout zone from 6,009' to 6,224' with 4 SPF, 0.34" EHD, 120 degree phasing, for a total of 32 holes. On the same date 500 gal 15% HCL was pumped then the well was fracture treated with 53,408 gal Delta 140 with 94,789# 20/40 BASF sand coated with SWNT. The average rate was 36.9 bpm, average pressure 882 psi, and the final frac gradient was 0.47 psi/ft.

On 7/23/08 a CFP with green bio ball was set at 5,931' the above well was then perforated in the Cliff House zone from 5,499' to 5,896' with 4 SPF, 0.34" EHD, 120 degree phasing, for a total of 30 holes. On the same date 500 gal 15% HCL was pumped then the well was fracture treated with 57,968 gal Delta 140 with 109,048# 20/40 BASF sand coated with SWNT. The average rate was 33.5 bpm, average pressure 1185 psi, and the final frac gradient was 0.48 psi/ft.
