


## **Hydrogeological Report for Bolack B LS #4 Existing Below Grade Tank (30-045-06600)**

### **General Geology and Hydrology**

The San Juan Basin is a typical asymmetrical Rocky Mountain basin with a gently dipping southern flank and a steeply dipping northern flank. Asymmetrically layered Tertiary sandstones and shales, along with Quaternary alluvial deposits dominate surficial geology (Dane and Bachman, 1965). The site is located near Largo Canyon. Regional topography of Largo Canyon is composed of mesas dissected by deep, narrow canyons and arroyos. The cliff-forming sandstones are more resistant than the shales, but eventually weather into their composite sands; the shale weathers into silts and clays, resulting in a highly erodible landscape and an abundant sediment supply (Brister and Hoffman, 2002). Accumulations of talus and colluvial sediment at the base of the canyon walls form steep to gentle slopes that transition into flat-bottomed arroyos within the canyons.

The predominant geologic formation in the Largo Canyon region is the Nacimiento Formation of Tertiary age, which underlies surface soils (Dane and Bachman, 1965). The Nacimiento Formation is made up of fluvial sandstones interbedded with siltstones and shales. The more resistant San Jose Formation caps the Nacimiento Formation in topographically high areas of the Largo Canyon region. The San Jose Formation is a sequence of alluvial interbedded sandstones and mudstones. Deposits of Quaternary alluvial and aeolian sands occur prominently near the surface of Largo Canyon, especially near streams and washes.

The San Jose and Nacimiento sandstones, as well as the Quaternary alluvial deposits, serve as the primary aquifers in the San Juan Basin (Stone et al., 1983). Porous sandstones form the principal aquifers, while relatively impermeable shales form confining units between the aquifers. Groundwater at the location is associated with the alluvial sandstone aquifers within the San Jose Formation. Specific groundwater behavior at the site is discussed in the Siting Criteria section.

The large expanses of exposed bedrock that characterize the area contain thin and rocky soils, if any. Most soils within the canyons are deep and well drained, formed from alluvial or residual materials derived from sandstone, siltstone and shale of the bedrock outcrops, slopes and mesa surfaces (Brister and Hoffman, 2002). Slopes within the canyon are a mixture of the two. Soils commonly consist of unconsolidated silts, sands and clays with deposition controlled by local ephemeral washes or arroyos. Aeolian sediments are also present. These consist of well-sorted sands and silts that interrupt the fluvial sequences. The variable fluvial and aeolian influences contribute to irregular grain sizes and thicknesses of subsurface soil layers. The sudden influx of water from storm events easily erodes soils that cover the area.

The climate of the Largo Canyon watershed is arid, averaging less than 10 inches of rainfall annually. As is typical of the southwestern United States monsoonal weather

patterns, most precipitation falls from July through September. The heaviest rainfall occurs in the summer in isolated, intense cloud bursts during which some recharge occurs where intermittent streams flow across sandstone outcrops. Water moves down the dip of sandstone beds along the channels of major streams through seeps and springs and along the walls of canyon cut by the streams. October through June is relatively dry. Snow generally falls from December to mid-February and averages less than one-half inch in depth. However, most recharge occurs during the winter months during snowmelt periods from the upper elevations (Western Region Climate Center, 2004).

The predominant vegetation is sagebrush and grasses with a more restricted pinon-juniper association. Riparian vegetation, including cottonwood and willow are observed along larger tributary canyons (Dick-Peddie, 1993).

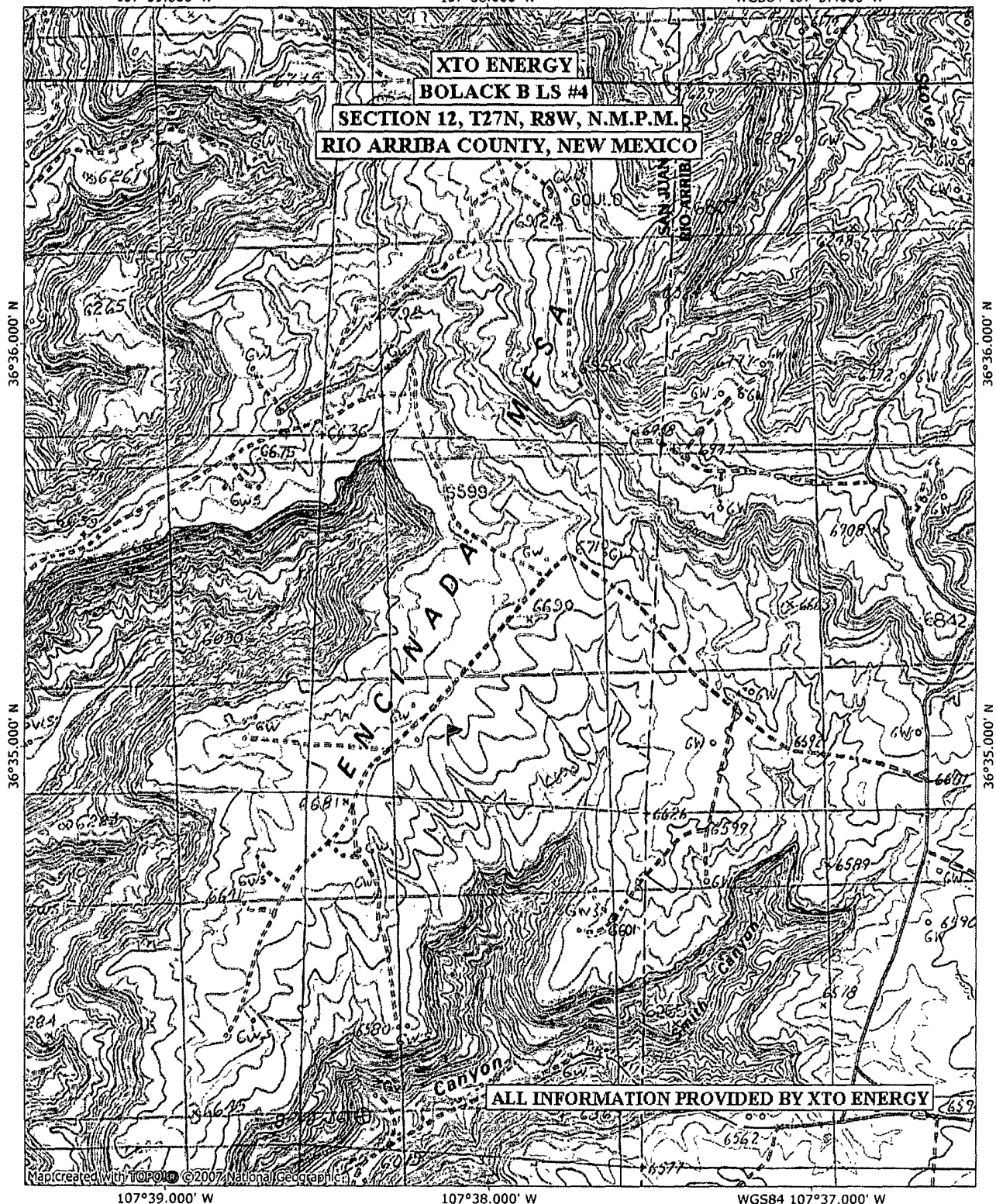
- Depth to Groundwater: Depth to groundwater is estimated to be greater than 100 feet based on the following observations:
  - This rural site location does not contain an abundant amount of groundwater elevation data. The closest public groundwater data exists approximately two miles away in T27N, R7W, section 17. A single data point from the NM State Engineer's Office iWaters database indicates groundwater at 320' in Section 17. A general comparison of site topography suggests similar properties. Both sections are characterized by shallow alluvial fans spreading onto a mesa top. The surface elevation is 6709.6 feet at the location and 6687 feet at the site of groundwater data.
  - As shown on the topographic map, Largo Wash is the closest surface water (intermittent surface water). Groundwater is estimated to be very near the ground surface within the wash. Largo Wash is approximately 2 miles from the location. The elevation change between Largo Wash and the location is approximately 236 feet. Cereza Wash (another ephemeral stream) is approximately 2.25 miles to the north of the site. The elevation change is 224' based on topographic contours.
- Surface Water: No continuously flowing watercourse exists within 13 miles of the location. Largo and Cereza washes are ephemeral, and are located almost 2 miles away, as measured on the topographic map.
- Private and Public Buildings: An aerial photo is attached and it is clear that no residences, schools, hospitals, public institutions or churches are located near the site.
- Private or Public Water Sources: The pit will not be located near any private fresh water well or spring. No water well was found within 2 miles of the site on the iWaters database, and no freshwater spring or seep is identified on the topographic map.
- Municipal Boundaries: The well site is not located within any incorporated municipal boundaries or municipal fresh water well field
- Wetlands: No wetlands are identified on the topographic map.
- Subsurface Mines: A NM Bureau of Geology and Mineral Resources map is attached showing the location of the site and any mines, mills or quarries nearby. There is no such operation within at least a 15-mile radius of the site.
- Site Stability: The site is located on an alluvial fan that gently spreads onto a mesa, and analysis of the topographic map indicates the area is stable.
- Floodplain: A FEMA floodplain map is attached, indicating the site is located in a zone that is defined as outside of the 500-year flood plain.

This is XTO's standard procedure for all below grade tanks. A separate plan will be submitted for any below grade tank (BGT) which does not conform to this plan.

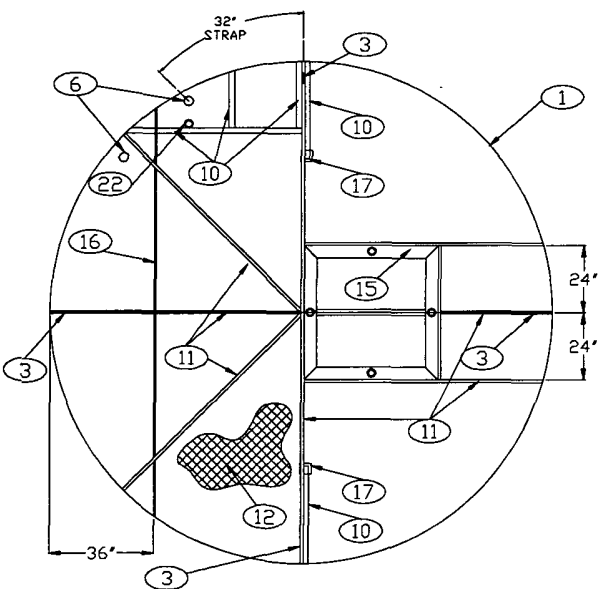
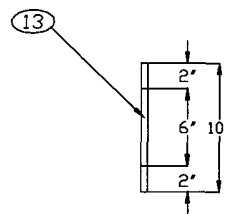
**General Plan**

1. XTO will design and construct a BGT to contain liquids and solids and prevent contamination of fresh water and protect public health and environment.
2. Prior to constructing the pit, topsoil will be stockpiled in the construction zone for later use in restoration.
3. XTO will post a well sign, in compliance with 19.15.3.103 NMAC, on the well site prior to construction of the BGT. The sign will list the Operator on record as the operator, the location of the well site by unit letter, section, township, range, and emergency telephone numbers.
4. XTO shall construct all new fences utilizing 48" steel mesh field-fence (hogwire) on the bottom with two strands of barbed wire on top, or with a pipe top rail. A 6' chain link fence topped with three strands of barbed wire will be used if the well location is within 1000' of a permanent residence, school, hospital, institution or church.
5. XTO shall construct an expanded metal covering on top of the BGT.
6. XTO will ensure that a BGT is constructed of materials resistant to the BGT's particular contents and resistant to damage from sunlight.
7. The BGT system will have a properly constructed foundation consisting of a level base free of rocks, debris, sharp edges or irregularities to prevent punctures, cracks or indentations of the liner or tank bottom.
8. XTO will construct a berm and/or diversion ditch in a manner that prevents the collection of surface water run-on.
9. XTO will construct and use BGT that does not have double walls. The BGT sidewalls will be open for visual inspection for leaks, the BGT bottom will be elevated a minimum of 6" above the underlying ground surface and the BGT will be underlain with a geomembrane liner to divert leaked liquid to a location that can be visually inspected.
10. XTO will equip BGT's designed in this manner with a properly functioning automatic high-level shut-off control device and manual controls to prevent overflows.
11. The geomembrane liner shall consist of 30-mil flexible PVC or 60-mil HDPE liner, or an equivalent liner material that the appropriate division district office approves. The geomembrane liner shall have a hydraulic conductivity greater than  $1 \times 10^{-9}$  cm/sec. The geomembrane liner shall be composed of an impervious, synthetic material that is resistant to petroleum hydrocarbons, salts and acidic and alkaline solutions. The liner material shall be resistant to ultraviolet light. Liner compatibility shall comply with EPA SW-846 method 9090A.

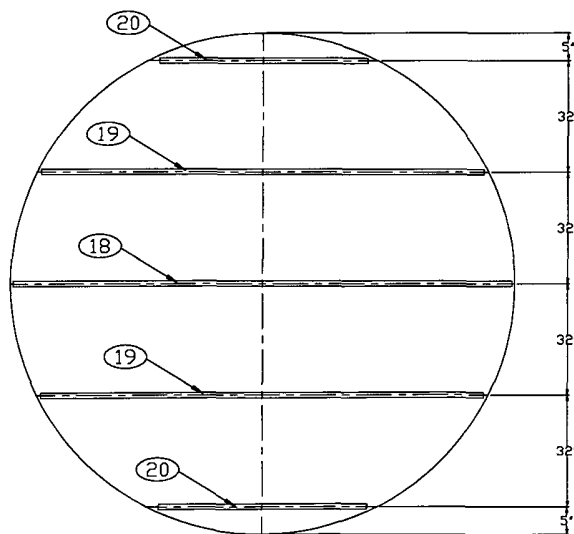

This is XTO's standard procedure for all below grade tanks. A separate plan will be submitted for any below grade tank (BGT) which does not conform to this plan.

**General Plan**

1. XTO will close a BGT within the time periods provided in 19.15.17.13 NMAC, or by an earlier date that the division requires because of imminent danger to fresh water, public health or the environment.
2. XTO will close an existing BGT that does not meet the requirements of Paragraphs (1) through (4) of Subsection I of 19.15.17.11 NMAC or is not included in Paragraph (5) of Subsection I of 19.15.17.11 NMAC within five years after June 16, 2008, if not retrofitted to comply with Paragraphs (1) through (4) of Subsection I of 19.15.17.11 NMAC.
3. XTO will close a permitted BGT within 60 days of cessation of the BGT's operation or as required by the transitional provisions of Subsection B of 19.15.17.17 NMAC in accordance with a closure plan that the appropriate division district office approves. The closure report will be filed on form C-144.
4. XTO will remove liquids and sludge from a BGT prior to implementing a closure method and will dispose of the liquids and sludge in a division-approved facility.
5. XTO will remove the BGT and dispose of it in a division approved facility or recycle, reuse, or reclaim it in a manner that the appropriate division district office approves.
6. XTO will remove any on-site equipment associated with a BGT unless the equipment is required for some other purpose.
7. XTO will test the solids beneath the BGT to determine whether a release has occurred. At a minimum 5 point composite sample will be collected along with individual grab samples from any area that is wet, discolored or showing other evidence of a release. Samples will be analyzed for BTEX, TPH and chlorides to demonstrate that the benzene concentration, as determined by EPA SW-846 methods 8021B or 8260B or EPA method that the division approves, does not exceed 0.2 mg/kg; total BTEX concentration, as determined by EPA SW-846 methods 8021B or 8260B or other EPA method that the division approves, does not exceed 50 mg/kg; the TPH concentration, as determined by EPA method 418.1 or other EPA method that the division approves, does not exceed 100mg/kg; and the chloride concentration, as determined by EPA method 300.1 or other EPA method that the division approves, does not exceed 250 mg/kg, or the background concentration, whichever is greater. XTO will notify the division of its results on form C-141.
8. If XTO or the division determines that a release has occurred, XTO will comply with 19.15.3.116 NMAC and 19.15.1.19NMAC as appropriate.
9. If the sampling program demonstrates that a release has not occurred or that any release does not exceed the concentrations specified in Paragraph (4) of Subsection E of 19.15.17.13 NMAC, XTO will backfill the excavation with compacted, non-waste containing, earthen material; construct a division prescribed soil cover; recontour and re-vegetate the site.
10. Notice of Closure will be given to the Aztec Division District III office between 72 hours and one week of closure via email or verbally. The notification will include the following:
  - i. Operator's name
  - ii. Location by Unit Letter, Section, Township, and Range. Well name and API number.

11. All closure activities will include proper documentation and be available for review upon request and will be submitted to OCD within 60 days of closure of the BGT. Closure report will be filed on form C-144 and incorporate the following:
  - i. Details on capping and covering, where applicable
  - ii. Inspection reports
  - iii. Sampling results
12. Re-contouring of location will match fit, shape, line, form and texture of the surrounding area. Re-shaping will include drainage control, prevent ponding, and prevent erosion. Natural drainages will be unimpeded and water bars and/or silt traps will be placed in areas where needed to prevent erosion on a large scale. Final re-contour shall have a uniform appearance with smooth surface, fitting the natural landscape.
13. XTO will seed the disturbed areas the first growing season after the operator closes the pit. Seeding will be accomplished via drilling on the contour whenever practical or by other division-approved methods. BLM or Forest Service stipulated seed mixes will be used on federal lands. Vegetative cover will equal 70% of the native perennial vegetative cover (un-impacted) consisting of at least three native plant species, including at least one grass, but not including noxious weeds, and maintain that cover through two successive growing seasons. Repeat seeding or planting will be continued until successful vegetative growth occurs.
14. A minimum of 4' of cover shall be achieved and the cover shall include 1' of suitable material to establish vegetation at the site, or the background thickness of topsoil, whichever is greater.
15. The surface owner shall be notified of XTO's proposal to close the BGT as per the approved closure plan using certified mail, return receipt requested.
