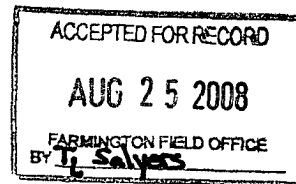

Cemented 1st stage w/200 sx (52 bbls) 50/50 POZ cement w/3% Gel, 5#/sx Gilsonite, 1/8#/sx Poly-E-Flake, 0.1% CFR 3, 0.6% Halad-9, TOC at HYD DV Tool 2,925'. Cement 2nd stage w/550 sx (147 bbls) 50/50 POZ w/3% Gel, 0.6% Halad-9, 0.1% CFR-3, 5#/sx Gilsonite, 1/4#/sx Flocele. Circulated 20 bbls of cement to surface. Tested casing to 1,500 psi, held ok. ✓
