XTO Energy Inc. spudded 17-1/2" conductor hole on 01/16/2008 & drilled to 105' (cond TD). Set 13-3/8", 48#, H-40 conductor casing @ 94' & cemented w/310 sx Type V cement (15.6 ppg & 1.18 cuft/sx). Circ 6 bbls cement to surface on 01/17/2008.

Drilled 12-1/4" surf hole to 890' on 01/19/2008 (surf TD). Set 9-5/8", 36#, J-55 surf casing @ 886' on 01/19/2008 & cemented w/485 sx Type III cement (15.6 ppg & 1.18 cuft/sx). Circ 50 bbls cement to surf. Finished cement job on 01/19/2008. Pressure Tested casing to 1000 psig f/30 min. Tested OK.
