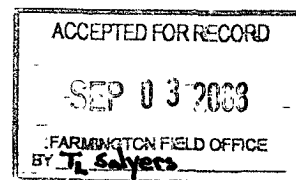

On 8/22/08, in 12-1/4" hole, ran 3 new joints of 8-5/8", 24# K-55 STC surface casing set at 132' KB. Cemented with 120 sacks Type G cement with 2% cacl2 and 1/4#/bbl superfake (yield 1.3 ft3/sk and wt=15.6 lb/gal). Displaced with 6.2 BBls of water. Good returns throughout job. Returned approximately 7 BBls of cement to pit. Shut in well with 100 psi. Pressure test casing to 600 psig. Held good. ✓
Total depth of surface hole = 137' (reached on 8/22/08). ✓
