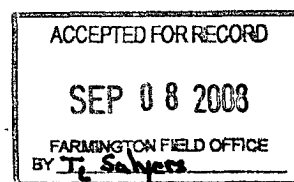

On 8/31/08, began drilling 7-7/8" hole from 137' to a total depth of 1565'. TD reached on 9/3/08. On 9/3/08, set 37 joints of new 5-1/2", 17#, J-55 production casing set at 1561' KB. Cement casing with 175 sacks 65/35 pozmix, 6% gel, 5# gilsonite, 1/4# superfake, mixed at 12.4 ppg. Tail cement 100 sacks Standard Class G cement, 5# gilsonite, 1/4# superfake, mixed at 15.2 ppg. Good returns throughout job. Circulate 15 BBIs good cement back to surface. Displace with 35.3 BBIs fresh water. Bump plug with 1100 psi, float held. Plug down at 12:52PM on 9/3/08. Release rig 9/4/08. ✓
