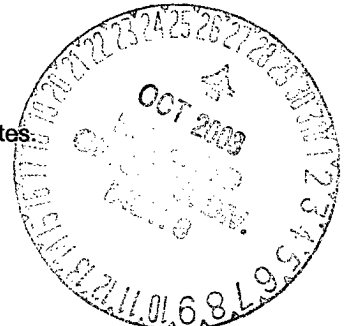

Pumped a preflush of 10 bbls dye water. Then pumped 200 sx (232 cf - 41.31 bbl slurry) Class G, 2% CaCl₂, 0.25#/sx Cello-flake. Dropped plug and displaced w/17.7 bbls water. Plug down @ 0356 10/13/04. Circ. 17 bbls good cement to surface. WOC. NU WH & BOP. PT BOP-OK. PT casing to 1000 psi for 30 minutes. Good test.
