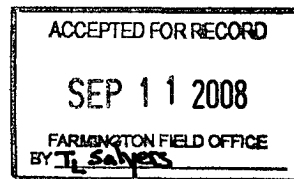

Production string was not cemented. Tested casing to 2500 psi, held ok. The rig was released on 8/28/08.
