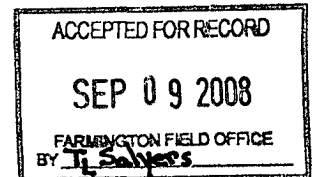

Cemented 1st stage with 210 sx (54 bbls) 50/50 POZ w/3% Gel, 0.6% Halad-9, 0.1% CFR-3, 5#/sx Gilsonite, 0.125#/sx Poly-E-Flake. TOC for stage 1 is at DV tool 2,860'. Cement 2nd stage with 590 sx (152 bbls) 50/50 POZ w/3% Gel, 0.6% Halad-9, 0.1% CFR-3, 5#/sx Gilsonite 0.25#/sx Flocele. Circulated 30 bbls of cement to surface. Tested casing to 1,500 psi, held ok. ✓
