Drilled 6 3/4" hole to 2265' and ran 4 1/2", J-55, 10.5# STC casing, landed casing @2253' KB. KB = 5'0"

Ran centralizers on the bottom 3 joints including shoe joint, and ran 2 turbulizers below the Ojo and the 1st joint into the Ojo. Pumped 14 sks 11# scavenger cement. Then lead with 232 sks 12.5# Class B Cement, with 2% Sodium Metasilicate, .25#/sk Cello Flake, 3 pps Gilsonite, 2# sk phenoseal, yield 2.09. Tail with 62 sks 14.5# Class B cement with 4% gel, 2% CaCl2, .25#/sk Cello Flake, yield 1.53. Had circulation throughout job, no cement returns to surface. Will run CBL & GSL at a later date.
