Casing standing full of water with poly pipe in well. **Plug #1** with 45 sxs Class B cement (54 cf) with 1% CaCl₂ inside the 4.5" casing from 396' to surface, circulate good cement out casing. POH with poly pipe. SDFD.

8/25/08 Road cement equipment to location and spot. RIH with poly pipe and tag at 25'. Issue Hot Work Permit. Cut off casing. Install P&A marker with 10 sxs Class B cement. RD and MOL.
