

On 8/23/08 the above well was perforated in the Point Lookout zone from 6,322' to 6,563' with 4 SPF, 0.34" EHD, 120 degree phasing, for a total of 32 holes. On the same date the well was fracture treated with 53,228 gal Delta 140 with 92,195# 20/40 BASF coated with SWNT sand. The average rate was 32.3 bpm, average pressure 665 psi.

On 8/23/08 a CFP was set at 6,300' then the above well was perforated in the Cliff House zone from 5,790' to 6,246' with 4 SPF, 0.34" EHD, 120 degree phasing, for a total of 33 holes. On the same date the well was fracture treated with 50,843 gal Delta 140 with 82,715# 20/40 BASF coated with SWNT sand. The average rate was 25.6 bpm, average pressure 1505 psi, and the final frac gradient was 0.59 psi/ft.
