

#### Hydro geological report for Marron #42B

#### Regional Hydro geological context:

The Marron #42B is located on Federal land on the first bench above Onofre Jaquez Wash. This small canyon drains in a northeasterly direction into the main Largo Wash in San Juan Country New Mexico. The area bounded by the sandstone cliffs is primarily dry, sandy soil with occasional boulders. There are numerous small arroyos which drain to Jaquez Wash.

A records search of the NM Office of the State Engineer – iWATERS database indicated that there was no depth to ground water data available in the entire township. The closest water well reported was in the SW/4 of Section 1, T26N, R8W which is approximately three miles south of the proposed location. This well was drilled to a depth of 180 feet with the top of the water column at 100'. The water from this well is used for livestock.

Geologic maps of the area indicate that the surface formation at the proposed well site is the San Jose formation. The San Jose Formation of Eocene age occurs in New Mexico and Colorado and its outcrop forms the land surface over much of the eastern half of the central basin. It overlies the Nacimiento Formation in the area generally south of the Colorado – New Mexico State line and overlies the Animas Formation in the area generally north of the State line.

The San Jose Formation was deposited in various fluvial-type environments. In general, the unit consists of an interbedded sequence of sandstone, siltstone and variegated shale. Thickness of the San Jose Formation generally increases from west to eat (200 feet in the west and south to almost 2,700 feet in the center of the structural basin).

Ground water is associated with alluvial and fluvial sandstone aquifers. Thus, the occurrence of ground water is mainly controlled by the distribution of sandstone in the formation. The distribution of such sandstone is the result of original depositional extent plus any post-depositional modification, namely erosion and structural deformation. Transmissivity data for San Jose Formation are minimal. Values of 40 and 120 feet squared or measured discharge from 46 water wells completed in San Jose Formation ranges from 0.15 to 61 gallons per minute and the median is 5 gallons per minute. Most of the wells provide water for livestock and domestic use.

The San Jose Formation is a very suitable unit for recharge from precipitation because soils that form on the unity are sandy and highly permeable and therefore readily absorb precipitation. However, low annual precipitation, relatively high transpiration and evaporation rates, and deep dissection of the San Jose Formation by the San Juan River and its tributaries all tend to reduce the effective recharge of the unit.

# M&G Drilling Company San Juan Basin Pit Design and Construction Plan

In accordance with Rule 19 15 17 the following information describes the design and construction for temporary pits on M&G Drilling Company's locations; this is M&G Drilling's standard procedure for all temporary pits. A separate plan will be submitted for any temporary pit which does not conform to this plan.

#### General Plan

- 1 M&G Drilling will design and construct a temporary pit to contain liquids and solids and prevent contamination of fresh water and protect public health and environment
- 2 Prior to constructing the pit, topsoil will be stockpiled in the construction zone for later use in restoration
- 3 M&G Drilling will post a well sign, not less than 12' by 14', on the well site prior to construction of the temporary pit. The sign will list the operator on record as the operator, the location of the well by unit letter, section, township rang, and emergency telephone numbers
- 4 M&G Drilling shall construct all new fences unitizing 48' steel mesh field-fence (hogwire) on the bottom with a single strand of barbed wire on top. T-posts shall be installed every 12 feet and corners shall be anchored utilizing a secondary T-post. Temporary pits will be fenced at all times excluding drilling or overwork operations, when the front side of the fence will be temporarily removed for operational purposes
- 5 M&G Drilling shall construct the temporary pit so that the foundation and interior slopes are firm and free of rocks, debris, sharp edges or irregularities to prevent liner failure
- 6 M&G Drilling shall construct the pit so that the slopes are no steeper than two horizontal feet to 1 vertical foot
- 7 Pit walls will be walked down by a crawler type tractor following construction
- 8 All temporary pits will be lined with a 20-mil, string reinforced, LLDPE liner, complying with EPA SW-846 method 9090A requirements
- 9 Geotextile will be installed beneath the liner when rocks, debris, sharp edges or irregularities cannot be avoided
- 10 All liners will be anchored in the bottom of a compacted earth-filled trench at least 18 inches deep
- 11 M&G Drilling will minimize liner seams and orient them up and down, not across a slope. Factory seams will be used whenever possible. M&G Drilling will ensure all field seams are welded by qualified personnel. Field seams will be overlapped four to six inches and will be oriented parallel to the line of maximum slope. M&G Drilling will minimize the number of field seams in corners and irregularly shaped areas
- 12 The liner shall be protected from any fluid force or mechanical damage through the use of mud pit slides, or a manifold system
- 13 The pit shall be protected from run-off by constructing and maintaining diversion ditched around the location or around the perimeter of the pit in some cases
- 14 The volume of the pit shall not exceed 10 acre-feet, including freeboard
- 15 Temporary blow pits will be constructed to allow gravity flow to discharge into lined drill pit
- 16 The lower half of the blow pit (nearest lined pit) will be lined with the same 20 mil liner. The upper half of the blow pit will remain unlined as allowed in Rule 19 15 17 11 F 11
- 17 M&G Drilling will not allow freestanding liquids to remain on the unlined portion of temporary blow pit

#### M&G Drilling Resources Operating LP San Juan Basin Maintenance and Operating Plan

In accordance with Rule 19 15 17 the following information described the operation and maintenance of temporary pits on M&G Drilling Company locations. This is M&G Drilling's standard procedure for all temporary pits. A separate plan will be submitted for any temporary pit which does not conform to this plan.

#### General Plan

- 1 M&G Drilling will operate and maintain a temporary pit to contain liquids and solids and prevent contamination of fresh water and protect public health and environment
- 2 M&G Drilling will conserve drilling fluids by transferring liquids to pits ahead of the rigs whenever possible. All other drilling fluids will be disposed at Basin Disposal, Inc. Permit # NM-01-005
- 3 M&G Drilling will not discharge or store any hazardous waste in any temporary pit
- If any pit liner's integrity is compromised or if any penetration of the liner occurs above the liquid's surface, then M&G Drilling shall notify the Aztec Division office by phone or email within 48 hours of the discovery and repair the damage or replace the liner
- If a leak develops below the liquid's level, M&G Drilling shall remove all liquids above the damaged liner within 48 hours and repair the damage or replace the liner. M&G Drilling shall notify the Aztec Division office by phone or email within 48 hours of the discovery for leaks less than 25 barrels. M&G Drilling shall notify the Aztec division office as required pursuant to Subsection B of 19 15 3 116 NMAC shall be reported within twenty-four (24) hours of discovery of leaks greater than 25 barrels. In addition, immediate verbal notification pursuant to Subsection B, Paragraph (1) and Subparagraph (d) of 19 15 3 116 NMAC shall be reported to the division's Environmental Bureau Chief
- The liner shall be protected from any fluid force or mechanical damage through the use of mud pit slides, or manifold system
- 7 The pit shall be protected from run-off by constructing and maintaining diversion ditches around the location or around the perimeter of the pit in some cases
- 8 M&G Drilling shall immediately remove any visible layer or oil from the surface of temporary pit after cessation of a drilling or workover operation. Oil absorbent booms will be utilized to contain and remove oil from the pit's surface. An oil absorbent boom will be stored on-site until closure of pit
- 9 Only fluids generated during the drilling or workover process may be discharged into a temporary pit
- 10 M&G Drilling will maintain the temporary pit free of miscellaneous solid waste or debris
- During drilling or workover operations, M&G Drilling will inspect the temporary pit at least once daily to ensure compliance with this plan. Inspections will be logged in the IADC reports. M&G Drilling will file this log with the Aztec Division office upon closure of the pit
- 12 After drilling or workover operations, M&G Drilling will inspect the temporary pit weekly so long as liquids remain in the temporary pit. A log of the inspections will be stored at M&G Drilling's office electronically and will be filed with the Aztec Division office upon closure of the pit
- 13 M&G Drilling shall maintain at least two feet of freeboard for a temporary pit
- 14 M&G Drilling shall remove all free liquids from a temporary pit within 30 days from the date the operator releases the drilling or workover rig
- 15 M&G Drilling shall remove all free liquids from a cavitations put within 48 hours after completing cavitations. M&G Drilling may request additional time to remove liquids from Aztec Division office if it is not feasible to remove liquids within 48 hours

#### M&G Drilling Company San Juan Basin Closure Plan

In accordance with Rule 19.15.17.12 NMAC the following information describes the closure requirements of temporary pits on M&G Drilling Company's locations. This is M&G Drilling's standard procedure for all temporary pits. A Separate plan will be submitted for any temporary pit which does not conform to this plan.

All closure activities will include proper documentation and be available for review upon request and will be submitted to OCD within 60 days of the pit closure. Closure report will be filed on C-144 and incorporated the following:

- Detail on Capping and Covering, where applicable
- Plot Plan (Pit diagram)
- Inspection reports
- Sampling Results
- C-105
- Copy of Deed Notice will be filed with County Clerk

#### General Plan

- All free standing liquids will be removed at the start of the pit closure process from the pit and disposed of in a division-approved facility or recycle, reuse or reclaim the liquids in a manner that the appropriate division district office approves
- 2 The preferred method of closure for all temporary pits will be on-site burial, assuming that all criteria listed in sub-section (B) of 19.15.17.13 are met
- The surface owner shall be notified of M&G Drilling's proposed closure plan using a means that provides proof of notice i.e., certified mail, return receipt requested
- Within 6 months of the Rig Off status occurring M&G Drilling will ensure that temporary pits are closed, re-contoured, and reseeded
- Notice of Closure will be given to the Aztec Division office between 72 hours and one week of closure via email, or verbally, The notification of closure will include the following:
  - i. Operator's name
  - Location by Unit Letter, Section, Township, and Range. Well name and API Number
- 6 Liner of temporary pit shall be removed above "mud level" after stabilization. Removal of liner will consist of manually or mechanically cutting liner at mud level and removing all remaining liner. Care will be taken or remove "All" of the liner i.e., edges of liner entrenched or buried. All excessive liver will be disposed of at a licensed disposal facility
- 7 Pit contents shall be mixed with non-waste containing, earthen material in order to achieve the solidification process. The solidification process will be accomplished using a combination of natural drying and mechanically mixing. Pit contents will be mixed with non-waste, earthen material to a consistency that is deemed a safe and stable. The mixing ratio shall not exceed 3 parts clean soil to 1 part pit contents
- A five point composite sample will be taken of the pit using sampling tools and all samples rested per Subsection B of 19.15.17.13(B)(1)(b). In the event that the criteria are not met, all contents will be handled per Subparagraph (a) of Paragraph (1) of Subsection B of 19.15.17.13 i.e., Dig and haul

- 9 Upon completion of solidification and testing, the pit area will be backfilled with compacted, non-waste containing, earthen material. A minimum of four feet of cover shall be achieved and the cover shall include one foot of suitable material to establish vegetation at the site, or the background thickness of topsoil, whichever is greater
- 10 Re-contouring of location will match fit, shape, line, form and texture of the surrounding area. Reshaping will include drainage control, prevent ponding, and prevent erosion. Natural drainages will be unimpeded and water bars and/or silt traps will be placed in areas where needed to prevent erosion on a large scale. Final re-contour shall have a uniform appearance with smooth surface, fitting the natural landscape
- 11 Notification will be sent to OCD when the reclaimed area is seeded
- 12 M&G Drilling shall seed the distributed areas the first growing season after the operator closes the pit. Seeding will be accomplished via drilling on the contour whenever practical or by other division-approved methods. BLM or Forest Service stipulated seed mixed will be used on federal lands. Vegetative cover will equal 70% of the native perennial vegetative cover (un-impacted) consisting of at least three native plant species, including at least one grass, but not including noxious weeds, and maintain that cover thorough twp successive growing seasons. Repeat seeding or planting will be continued until successful vegetative growth occurs
- 13 The temporary pit will be located with a steel marker, no less than four inches in diameter, cemented in a hole three feet deep in the center of the onsite burial upon the abandonment of all the wells on the pad. The marker will be a four foot tall riser with the operator's information at the time of all wells on the pad are abandoned. The operator's information will include the following: Operator Name, Lease Name, Well Name and Number, unit Number, Section, Township, Range and an indicator that the marker is an onsite burial location
