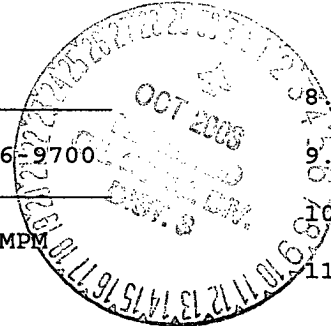

13. Describe Proposed or Completed Operations

It is intent to deepen this existing Basin Fruitland Coal well to approximately 3809' into the Pictured Cliffs formation. It is anticipated the Pictured Cliffs is not productive in this wellbore. The existing tubing and liner will be pulled, the hole will be circulated cleaned, additional footage will be drilled (85' beyond current TD or last significant coal) and again the hole will be cleaned, and then a 5 1/2" 15.5# J-55 liner will be installed at approximately 3369' - 3721'.

A mud log will be ran.
