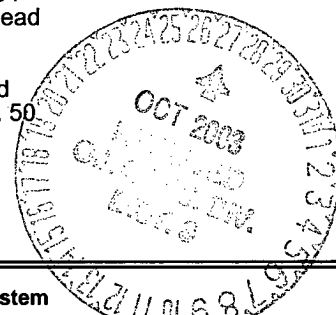

RU Schlumberger to cement. Pumped a preflush of 30 bbls water w/dye in last 10 bbls. Pumped Lead - 530 sx (1383 cf - 246.3 bbl slurry) Class G, 3% Extender, 0.2% Anti-foam, 5#/sx Pheno-seal, 0.25#/sx Cello-flake. Tail - 245 sx (311 cf - 55.38 bbl slurry) Class G, 50/50 POZ, 0.25# sx Cello-flake, 5#/sx Gilsonite, 2% Bentonite, 0.2% Antifoam, 2.5#/sx Pheno-seal, 2% CaCl<sub>2</sub>. Dropped plug & displaced w/91.6 bbls 2% KCL water. Bumped plug @ 1500 psi @ 0745 hrs 10/11/03. Circ. 50 bbls good cement to surface. ND BOP, set slips and cut off casing. RD & released rig @ 1200 hrs 10/11/03. Will show casing PT on next report.
