Cemented with 50 sx (59 cu.ft.) of CI "B" with 3% CaCl2 and 1/4# celloflake. No cement returns. Mixed 25 sx (30 cu. ft.) class "B" with 3% CaCl2, 1/4# celloflake. Cement returned. Displaced cement with 4.0 bbls of water at 1 BPM. Circulated 5.0 bbls of good cement to surface.
