**Black Hills Gas Resources had intended to plug back this well and abandon the Pictured Cliffs and Fruitland Coal. The Jicarilla Apache Nation Department of Water Administration had initially indicated that they wanted to keep this well for a water supply well. This decision was recinded 10-03-08. The FAX indicating same is attached. The well will be plugged and abandoned by the addition of a cement plug from 312 ft to surface. This change has been verbally approved by S. Mason Farmington BLM office 10-03-08.**
