**Current Status:** Location is built with open reserve pit. It is BP's intent to close the pit with in the next 3 months according to closure plan on file and restore surface location to Interim Restoration status per APD stipulations.

Because BP America's 2007 drilling program is on hold we respectfully request permission to hold said location in suspense status until June 2008. *If the location does not have surface casing set then it will be treated as a P&A location and rehabed accordingly.*
