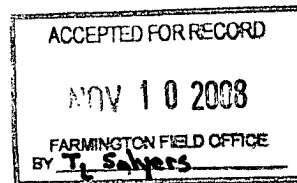

Circulate 280 bbls cement to surface. ✓ WOC. RD Halliburton. NU BOP. Test casing & BOP to 1200 psi - ok. ✓
