The operator is requesting permission to temporarily abandon this well. This well was inadvertently perforated in the Fruitland Coal, when it was permitted as a Pictured Cliffs well. The Fruitland Coal was perforated from 1077'-81'; 1116'-19'; 1135'-42'; 1169'-22'; 1232'-49' & 1256'-61' (total 39', 156 holes). We will evaluate the existing Fruitland Coal well dedicated to this acreage and if it appears that this well will produce at a greater rate, we will plug that well and complete this well. If the existing Fruitland well appears to be more productive than is possible from this well, then this well will be plugged. The casing will be pressure tested to 500 psi below a packer set at approximately 1050'. This well will not be produced while the existing well is being produced. We need three years to make a productive determination of the existing well.
