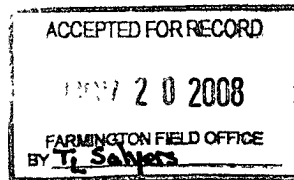

On 11/17/2008, set 8 jts of 5 1/2", J-55, 15.5#, ST&C Liner, run to 3190' with 0 sx of cement. Top of liner hanger is at 2837'. Perforations are from 2942' - 3181', 4 SPF, 0.52", 332 holes, 120 degree phasing. ✓
