Perf's from 3214' - 3323'; 3344' - 3387' and 3430' - 3452'. RIH w/mill and knocked off plug plugs. RIH w/56 jts 2-7/8", 6.5# J-55 EUE 8rd tubing and landed @ 3435' w/FN @ 3401'. RIH w/pump & rods & spaced out. Test tubing and pump to 500# - OK. RD & released rig on 11/4/08 @ 1400 hrs.
