Cmted 2nd stage w/100 sx (192 cf) Extendacem cmt w/5# gilsonite, 1/8# polyflake & tailed w/225 sx (322 cf) Extendacem cmt w/5# gilsonite, 1/8# polyflake. Circ 10 bbls cmt to surface. On 11/9/08, pressure tested 7" csg to 1000 psi for 30 min - OK.
