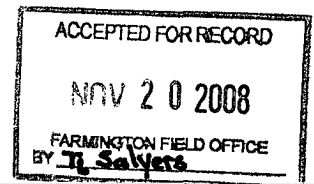

Circulated 20 bbls of cement to surface. Tested casing to 1,500 psi for 30min-held ok. ✓
