Elm Ridge Exploration Co LLC, has spud the above well on 11-13-08 we drilled to 45' with a 12 1/4" hole. On 11-21-08 we drilled to 396' and ran 9 joints of 8 5/8" 24# J-55 casing to 387'. We then pumped 400 sks of Type G with 2% calc 1/8# polyflake cement with 20 bbls of good cement to surface. Pressure tested well to 1500 PSI for 30 plus minutes, tested good. Lester with the BLM was notified of spud and surface casing/cement job but, was not present to witness. Rig down Triple P#14 and move off of location on 11-22-08. ✓
