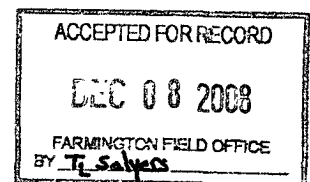
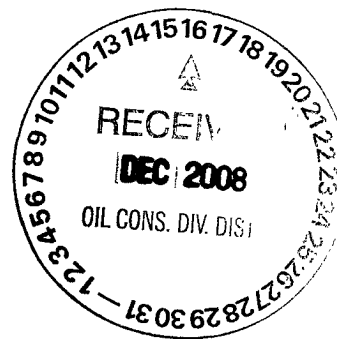

The 4.50" liner was set @ 8222' which is 1647' above our MD TD. This was due to a pipe tally miscalculation by the rig consultant. We proceeded to complete the Lewis Shale with a 5-stage frac job.
