Cmted w/80 sx (150 cf) Howco lite cmt w/5# gilsonite, 1/8# polyflake & tailed w/65 sx (93 cf) 50/50 POZ cmt w/5# gilsonite & 1/8# polyflake. Circ 11 bbls cmt to surface. Plan to pressure test the 4-1/2" csg during completion operations. Released the drilling rig on 12/1/08.
