BP America Production Company respectfully request authorization to surface commingle gas production from the Blanco Pictured Cliffs which is coming from our Barrett A 12 well API 30-045-26824 and Blanco Mesaverde production coming from the Barrett LS 2B well API 30-045-31028. The production from each well will be separated prior to the allocation meter. Then the production from each well will be metered prior to being commingled. The commingled production will then be sent through compression prior to entering the sales meter.

The difference between what is measured prior to commingling and what is sold through the sales meter is the fuel usage. This fuel usage is allocated back to each well based on the well production.

The working interest, royalty and overriding royalty interest owners in the subject wells **are the same**, therefore no notification will be required. The proposed commingling of production is to reduce operating expenses between the wells and will result in increased economic life of the wells.
