In accordance with Rule 19.15.17 NMAC the following information describes the design and construction of below grade tanks on Devon Energy Production Company, L.P. locations. This is Devon Energy's standard procedure for all below grade tanks (BGT). A separate plan will be submitted for any BGT which does not conform to this plan.

General Plan

- 1) Devon Energy believes it is beneficial at this time to replace the existing 80bbl tank with a new 80bbl tank. The new tank will be double wall and double bottom with leak detection.
- 2) When we remove the 80bbl tank, if there is any visible contamination we will take the necessary measures to follow the appropriate OCD mediation requirements.
- 3) At the time of removal, no other modifications to the original plan will be made.
