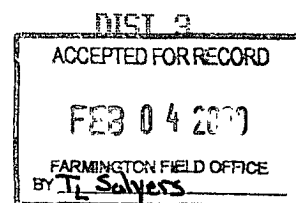

Top of liner set at 4058' KB; 127' overlap, 7' csg at 4185'. Cemented with 250 sks (330 cf) 50/50 Poz G + 2% gel + 5 lbs/sk Gilsonite + 3% KCL + 1/8 lbs/sk Pol-E-Flake + 0.4% HR9 + 0.2% HR5 mixed at 13.5 ppg, yield 1.32 cf/sk. Circ 15 bbl cmt off of liner top to surf. Pressure test casing to 3000 psi, for 30 min, ok - per operator
