Drill 12-1/4" hole to 288. On 11/23/02 ran 9-5/8", 32.3#, H-40 casing. Set at 279'. Cement with 200 sacks (42 bbls) Class B, 2% CaCl2, and 1/4# Flocele. Yield 1.18. Circulate 23 bbls cement to pit. Pressure test casing to 1500 psi.

Drill 8-3/4" hole to 3632. On 11/29/02 ran 7", 23# J-55 casing. Set at 2242'. Cement with 500 sacks (20 bbls) 50/50 POZ, 2% gel, 2/10% diacel and 1/10% LWL, yield 1.45. Circulate 62 bbls cement to pit. Pressure test casing to 1500 psi.

Drill 6-1/4" hole to 8130'. On 12/6/02 ran 4-1/2", J-55, 11.6# LT&C casing. Set at 8130'. Cement with 500 sacks (130 bbls) 50/50 POZ "B", 1.47 yield. 3% gel, .9% Halad 9, .2% CFR-3, 5# PSX gilsonite, 1/4# PSX Flocele. TOC 5708'. Pressure test casing to 2500 psi.
