Energen Resources intends to plug back the Jicarilla 96 4R as follows:

1. MIRUPU. NDWH. NU the BOP.
2. POOH w/ the 2 3/8" tubing. TIH w/ 4 1/2" CIBP and set at 5,529'.
3. Mix and pump 12 sx. of cement on top of CIBP. Wait 4 hours and tag cement. POOH w/ tubing.
4. TIH w/ 7" CIBP and set at 4,035'. Pressure test to 1,000#.
5. Mix and pump 28 sx. of cement on top of CIBP. Wait 4 hours and tag cement. POOH w/ tubing.
6. RWL and RIH to set a quick drill bridge plug 100' below proposed bottom perf in Picture Cliffs.
7. Perforate, acidize and fracture Picture Cliffs.
8. TIH w/ tubing and clean out to bridge plug. Circulate clean. POOH w/ tubing.
9. TIH w/ production equipment.
10. ND the BOP. NUWH. Clean location. RDPUMD.
