The Filan #1 had a scrubber malfunction which caused an actual vacuum at the compressor inlet which pulled in oxygen. Enterprise is taking unilateral action to shut it in until a Vacuum Agreement is signed by the producer. Enterprise's vacuum Agreement is in an onerous agreement. Until a complete new commercial agreement is reached between BR and Enterprise, Enterprise has allowed BR to produce the well, without compression, for 1 day a year to re-establish the commercial viability of the well. We will continue to do so until said agreement is signed with Enterprise.
