The following work was performed on the subject well after high concentrations of H2S were encountered from well

MIRU service unit and H2S safety company.

Set 5-1/2" plug in casing at 3515' and test to surface- failed.

Set 7-5/8" packer at 2909' and test 5-1/2' stub and casing below to 500 psi- good test.

Found holes in 7-5/8" casing at 888', 873', and 763'.

Run 67 jts 5-1/2" 15.5# casing from stub at 2909' to surface.

Cemented casing w/ 175 sx 50/50 Poz and tail in w/ 75 sx Class "B" neat.

Closed Intermediate valve and pressured up to 2000 psi to holes in 7-5/8" casing. (5 bbls to surface)

Drilled out cement and pressure tested casing to 1500 psi to RBP at 3515'.

Ran 2-3/8" production tubing in well and landed at 5512'.

Turned well to sales w/ 0 PPM H2S.
