Pumped a preflush of 5 bbls FW, 10 bbls #10 Gel w/2#/bbls cemnet & 5 bbls FW w/dye. Pumped Lead - 450 sx (1174.5 cf - 209.2 bbl slurry) Class G cement w/3% Extender, 0.25#/sx cellophane, & 0.2% Antifoam. Tail - 100 sx (127 cf - 22.5 bbl slurry) 50/50 Class G POZ w/2% gel, 5#/sx Gilsonite, 2% BWOC CaCl2, 0.25#/sx Cellophane & 0.2% Antifoam. Released wiper plug and displaced plug w/20 bbls FW followed by 117 bbls 9.3 ppg mud. Bumped plug w/1450 psi @ 0130 hrs 12/4/03. Circ. 45 bbls good cement to surface. RD Schlumberger. ND BOP, set slips and cut off casing. Installed trash cap. RD & released rig 12/4/03. Will show casing PT on next report.
