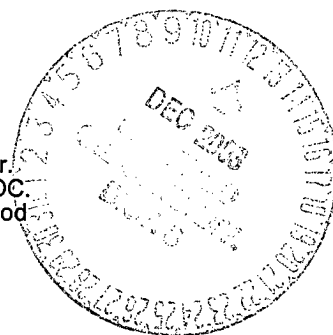

Pumped a preflush of 10 bbls dye water ahead of 150 sx (201 cf - 36 bbl slurry) STD 50/50 POZ, 2% Bentonite, 5#/sx Gilsonite, 0.2% CFR-3, 3% CaCl₂, 0.25#/sx Cello-flake. Dropped plug and displaced w/15 bbls water. Bumped plug to 150 psi. Plug down @ 0621 hrs 11/30/04. Circ. 8 bbls good cement to surface. WOC. NU WH & BOP. PT-OK. PT casing, rams and lines to 300# low and 1000 # high for 30 minutes. Good test.
