Tail - pumped 100 sx (127 cf - 22.5 bbl slurry) 50/50 Class G POZ w/2% gel, 5#/sx Gilsonite, 2% CaCl2, 0.25#/sx Cellophane, 0.2% antifoam. Released wiper plug and displaced w/129 bbls FW.
