Pumped 30 bbls water w/dye in last 10 bbls. Pumped Lead - 310 sx (893 cf) STD, 3% Econolite, 10#/sx Pheno-seal. Tail - 190 sx (252 cf) STD 50/50 POZ, 2% Bentonite, 6#/sx Phenoseal. Dropped rubber plug and displaced w/125 bbls water. Bumped plug w/1150 psi. Circ. 84 bbls good cement to surface. ND BOP, set slips and cut off casing. NU B Section & BOP. RU for air drilling. PT BOP, rams, manifold and lines to 3000 psi low and 3000 psi high. PT casing to 1800 psi for 30 minutes. Good test.
