Devon Energy plans to set an isolation plug below the MV as follows: Lower the 2-3/8" tbg in the hole to tag the top of junk-in-the-hole, formerly at ~6562'. The decision will then be made as to which of the following plugging procedures to initiate.

A. With the 2-3/8" tbg just above the top of the junk (~6562'), spot 8 sx neat cmt (100' in 4-1/2" csg). WOC. Lower tbg & tag & record cmt top. Continue spotting & tagging until the top of cmt is above 6400'.

B. TOH w/tbg. Run 3-7/8" tapered mill on 2-3/8" tbg as a gauge ring. Mill as required to get through tight spots ~6300'-6400'. TOH. Using wireline, set 4-1/2" CIBP just above top of junk & top w/35' cmt.
