## **Plugging Summary:**

4/09/09 MOL and RU. SDFD.

4/13/09 Check well pressure: tubing, 13 PSI; casing, 600 PSI. LO/TO equipment on location. Bleed down well. ND wellhead. NU BOP, test. Unseat and remove donut. TOH and tally 75 stands tubing; total 4652'. Round trip 4.5" casing scraper to 4660'. TIH with 4.5" DHS CR and set at 4654'. Pressure test tubing to 100 PSI, held OK. Sting out of CR. Load the casing with 116 bbls water and circulate the well clean. Pressure test casing to 800 PSI, held OK.

**Plug #1** with CR at 4652', spot 38 sxs Class B cement (45 cf) inside casing above CR up to 4149' to isolate the Mesaverde perforations and cover the top.

PUH to 3810'. Load hole with 15 bbls of water.

**Plug #2** spot 36 sxs Class B cement (43 cf) inside casing from 3810' up to 3528' to cover the 7" casing shoe and the top of the 4.5," liner. PUH with tubing. SI well. SDFD.
