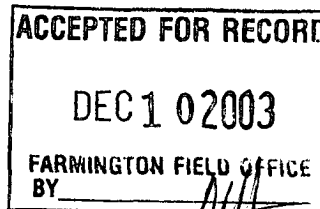

Work was completed to open the Dakota in the subject well. The Dakota was covered w/ a CIBP after significant gas shows in the Mancos. We have now removed the plug over the Dakota and run a production packer between the Mancos and Dakota. The packer is set at 7331' and the end of 2-3/8" tubing at 8087'. The ges from each zone will be individually monitored to establish a decline curve on the Dakota and then the packer will be removed and the well will be turned on as a Dakota/Mancos downhole commingle.
