Drilled 12-1/4" hole to 290'. Set 6 jts 9-5/8" 36# K-55 casing at 282'. Cemented with 175 sx (37 bbls) Class "B" cement 1/4 #/sx Flocele and 2% CaCl2. Circulate 15 bbls to surface. Pressure test casing to 1500 psi.

Drilled 8-3/4" hole to 4230' TMD. Set 95 jts 7" 23# J-55 casing at 4190' TMD. Cement w/ 643 (168 bbls) sx 50/50 Pc Gel, 0.4% Halad 344, 0.2% CFR-3, 5 #/sx Gilsonite, and 1/4 #/sx Flocele. Tail in w/ 75 sx Class "B" w/ 0.4% Halad. Circulated 15 bbls to surface. Pressure tested casing to 1500 psi.

Drilled 6-1/4" hole to 4513' TMD. Underream hole to 9-1/2" to 4513' TMD. Utilized natural and air assisted surges to clean material from near well bore. No casing was run in this section of hole and no cement was pumped. Landed 2-3/8" 4.7# J-55 tubing at 4426' TMD in openhole.
