Burlington Resources Oil & Gas, LP wishes to change the production casing string from running 4-1/2" 11.6#, L-80 LTC from surface to TD to 4-1/2", 11.6#, J-55 LTC from TD of 8226' to @ 4047' and then running 4-1/2" 11.6#, L-80 LTC from 4047' to surface. This change still exceeds the minimum requirement of 1.1 burst, 1.25 collapse and 1.8 tension. ✓
