Bumped plug w/730 psi @ 0430 hrs 12/5/03. Circ. 15 bbls good cement to surface. RD Schlumberger. WOC. NU WH & BOP. PT BOP-OK. PT casing, inner choke lines valves & rams to 350 psi for 3 minutes and 1150 psi for 1220 psi for 30 minutes. Good test.
