COOH. RIH w/7", 20#, J-55 ST&C casing and set @ 3382'. RU Halliburton to cement. Pumped a preflush of 30 bbls water w/dye in last 10 bbls. Pumped 410 sx (1181 cf - 210 bbl slurry) STD, 3% Econolite, 10#/sx Pheno-seal. Tail - 240 sx (319 cf - 56.8 bbl slurry) STD 50/50 POZ, 2% Bentonite, 6#/sx Pheno-seal. Dropped plug and displaced w/135 bbls water. Bumped plug w/1500 psi @ 0242 hrs 12/6/03. Circ. 135 bbls good cement to surface. ND BOP, set slips and cut off casing. NU B-Section. NU BOP, WOC.
